(FAX) abrdn World Healthcare Fund (THW) abrdn Global Dynamic Dividend Fund (AGD) abrdn Global Premier Properties Fund (AWP) abrdn Global Income Fund, Inc. (FCO) abrdn National Municipal Income Fund (VFL)

Each closed-end fund listed above (each a "Fund" and collectively, the "Funds") announced today that it paid on January 31, 2025, a distribution to all shareholders of record as of January 24, 2025 (ex-dividend date January 24, 2025).

Under U.S. tax rules applicable to the Funds, the amount and character of distributable income for each fiscal year can be finally determined only as of the end of the Funds' fiscal year. However, under Section 19 of the Investment Company Act of 1940, as amended (the "1940 Act") and related Rules, the Funds may be required to indicate to shareholders the estimated source of certain distributions to shareholders.

The following tables set forth the estimated amounts of the sources of the distributions for purposes of Section 19 of the 1940 Act and the rules adopted thereunder. The tables have been computed based on generally accepted accounting principles. The tables include estimated amounts and percentages for the current distributions paid this month as well as for the cumulative distributions paid relating to fiscal year to date, from the following sources: net investment income; net realized short-term capital gains; net realized long-term capital gains; and return of capital. The estimated compositions of the distributions may vary because the estimated composition may be impacted by future income, expenses and realized gains and losses on securities and currencies.

The Funds' estimated sources of the distributions paid this month and for their current fiscal year to date are as follows:

Where the estimated amounts above show a portion of the distribution to be a "Return of Capital," it means that Fund estimates that it has distributed more than its income and capital gains; therefore, a portion of your distribution may be a return of capital. A return of capital may occur for example, when some or all the money that you invested in a Fund is paid back to you. A return of capital distribution does not necessarily reflect the Fund's investment performance and should not be confused with "yield" or "income."

As of January 15, 2025, after giving effect to this payment THW estimates it has a net deficit of \$3,472,000, ACP estimates it has a net deficit of \$388,828,000. As of January 22, 2025, after giving effect to this payment FCO estimates it has a net deficit of \$11,504,000. A net deficit results when the Fund has net unrealized losses that are in excess of any net realized gains that have not yet been distributed.

Shareholders should not draw any conclusions about the Fund's investment performance from the amount of the Fund's current distributions.

The amounts and sources of distributions reported are only estimates and are not being provided for tax reporting purposes. The final determination of the source of all distributions in 2025 will be made after year-end. The actual amounts and sources of the amounts for tax reporting purposes will depend upon the Fund's investment experience during the remainder of the fiscal year and may be subject to change based on tax regulations. The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report these distributions for federal income tax purposes.
